- 4. Two-time use per quarter allowance for eligible items. Unused allowance cannot be rolled over into the next quarter/month.
- 5. If a beneficiary is in the exclusively-aligned enrollment (EAE) BlueShield TotalDual Plan and qualify for Low Income Subsidy (LIS), then they are eligible to receive Value Based Insurance Design (VBID) benefits. Covered program benefits include the Healthy Grocery and Expanded Non-Medical Transportation benefits.
