# Additional updates:

 Effective April 1, 2023, Blue Shield of California Promise Health Plan will begin insourcing coordination and management of all Medi-Cal behavioral health services that are currently managed by Carelon Behavioral Health, formerly known as Beacon Health Strategies.

- Also on April 1, 2023, DHCS will resume redetermination of coverage eligibility for Medi-Cal members.
- Providers should bill using valid Medi-Cal codes and following Medi-Cal guidelines for modifier requirements. Please visit the Medi-Cal website for detailed billing information.
